What is the new export tax rebate rate?

The world's second largest economy said on Friday that, starting December 1, it will reduce the export tax rebate rate for some refined oil products, photovoltaics, batteries and certain non-metallic mineral products from 13% to 9%.

What is the new export tax rebate rate in 2024?

Starting from 1 December 2024,the export tax rebate rate for some refined petroleum products,PV products,batteries and some non-metallic mineral products will be lowered by four percentage points,from 13% to 9%.

What is China's Export tax rebate rate?
