Battery Energy Storage Systems (BESS) were also exempt but with the condition that they must be installed alongside other energy-saving materials, such as solar. However, in a statement released on 11th December, the UK government made a noteworthy announcement--retrofitted BESS will now also be exempt from VAT.

"By allowing solar power to be used after dark, it can double the savings offered by home solar power systems.

When will 0% VAT on battery storage installations come into effect?

The upcoming 0% VAT on battery storage installations will come into effect on 1st February 2024. The exemption will apply to homes across the entire UK. Other ESMs have also been added to the VAT exemption list,including water-source heat pumps and retrofitted immersion diverters.
