Illegal removal of batteries

How should vehicle batteries be disposed of in the UK?

There are strict regulations on how vehicle batteries should be disposed of in the UK. According to the regulations, all vehicle batteries must be disposed of at a licensed recycling facility- you are not allowed to dispose of them with household waste collections. It is illegal to do so or place them into landfill.

Is it illegal to landfill a battery?

It is illegalto landfill,incinerate or improperly dispose of spent batteries; and all spent batteries collected must undergo treatment and recycling (Article 12.1b Directive). These are reinforced in the proposal for a new Batteries Regulation.

Where can I recycle a battery?

There should be a collection point at the premises for 'portable' batteries. These include AAA, AA and 9V batteries, battery packs, button batteries and rechargeable batteries, which can be found in a huge range of products. Basically, all batteries apart from those designed for vehicles or industrial use can be dropped off for recycling this way.

Can I treat or export a battery?

Please note that you cannot treat or export automotive or industrial batteries without approval being granted. You must follow extra rules if you manage waste batteries, including collection, treatment, recycling and export. These are in addition to your duty of care and hazardous waste regulation requirements.

How do I export battery waste to the UK?

ABEs must follow the Waste Shipment Regulations. Use the waste export control tool to find the regulatory controls for your battery waste's destination country. Follow the waste export and import guidance to move waste batteries or waste battery materials like lead plates in or out of the UK for treatment and recycling.

Can a car battery be recycled?

According to the regulations, all vehicle batteries must be disposed of at a licensed recycling facility- you are not allowed to dispose of them with household waste collections. It is illegal to do so or place them into landfill. Once you have disposed of the old and used vehicle battery legally and correctly, it should be recycled.
