#### Can I Sell my solar panels if I don't have a professional installer?

In short,yes. However,forgoing the help of professional installers will impose a number of additional legal responsibilities on yourself. MCS-Certifications are required for your solar panels when you choose to sell your property with the panels included.

#### Will there be VAT on solar panels in the UK?

No, there will be no tax on domestic solar panels in the UK until at least 2027. It was announced by ex-Chancellor Rishi Sunak that the VAT on energy efficient systems within the home should be cut from 5% to zero as of April 2022, until 2027.

#### Are solar panels tax-free?

Income generated under the new SEG scheme is still tax-free, although the significant reduction in payments compared to the Feed-in Tariff still impacts the amount of profit that can be made from domestic solar panels.

#### Can I install solar panels on my property?

If your property is situated in a conservation area, it may be possible to install solar panels under Permitted Rights. However, if the panels are to be installed such that it would be visible from a highway, a planning application and consent from the local authority will be necessary.
