Does a capacitor contain PCBs?

The absence of a capacitor from the following list is not a guarantee that the capacitor does contain PCBs: it is possible that the capacitor has not yet been tested to determine whether it contains PCBs. If there is any doubt as to whether a capacitor or any electrical equipment contains PCBs, treat the equipment as if it does contain PCBs.

Are there PCBs in capacitors & transformers made before 1976?

You should assume that any capacitor or transformer manufactured before 1976 may contain PCBs unless you have information to the contrary. It is also possible that there may be PCBs present in capacitors and transformers manufactured between 1976-1986.

What happens if a capacitor is damaged?
